22nd October 2018 Multiple Choice Competitions

Theme: Legal Rights of Women

Sarojini Naidu Centre for Women's Studies Jamia Millia Islamia under the aegis of National Commission for Women is organizing a multiple choice competition on 20th November 2018 based on the guidelines provided by the commission to create awareness among university students about the legal rights of women.

Interested participants should contact the undersigned for registration and participation in the competition. Details of the competition programme are as follows:

Instructions:

- The competition is open for all students (UG, PG, Research Scholars, of all courses offered by the university).
- A single set question paper based on multiple choice items will be given to the participants.
- The question paper will consist of a total 75 questions to be completed in 1 hour 15 minutes.
- Each correct answer of the question stands for 2 marks and no negative marking for wrong answer

Venue: Room No. 504, office of the controller of examination, Jamia Millia Islamia

Date & Time: 20th November 2018, 10: 30 AM to 11:45 AM.

The questions will cover the topics relating to the following laws:

1. Constitution of India mainly, the preamble, fundamental rights, directive principles of state policy, fundamentals duties, including article 33 and article 226 thereof.
2. National Commission for Women Act, 1990 (20 of 1990).
3. Dowry Prohibition Act, 1961.
4. Protection of Women from Domestic Violence Act, 2005.
5. The Sexual Harassment of Women at Work Place (Prevention, Prohibition and Redressal Act) Act, 2013.
6. The Criminal Law Amendment Act, 2013.
7. The Maternity Benefit Act, 1961.
8. The Medical Termination of Pregnancy Act, 1971 (34 of 1971).
9. The Immoral Traffic (Prevention) Act, 1956.
10. The Pre-Conception and Pre-Natal Diagnostic Techniques (Prohibition of Sex Selection) Act, 1994.
11. The Minimum Wages Act, 1948.
12. SC and ST (Prevention of Atrocities) Amendment Act, 2015.
13. The Scheduled Tribe and other Traditional Forest Dweller (Recognition of Forest Right Act, 2008
14. Major International Conventions related to elimination of discrimination and violence against women

The last date for registration is 15th November 2018

Registration for participants is free. However, the participants have to fill the registration form and submit it to the Coordinator/Deputy Coordinator on or before the last date in the office of Sarojini Naidu Centre for Women's Studies, Jamia Millia islamia

Participation certificate will be given to all the participants. However, cash prizes will be given to the winners only.

Cash Prize:

1. First Prize: 2000/-
