6.		<p><u>Add the new sub para 6(A):</u></p> <p>6(A) Special provision for candidates suffering from hearing impairment.</p> <p>The Controller of Examinations is authorized to issue extra time schedule for the candidates suffering from hearing impairment determining the benchmark disabilities.</p> <p>The Controller of Examinations, on receiving an Application along with the relevant medical records from the candidate one week before commencement of Examination, will arrange for the appointment of a Sign Language Expert and shall inform the Superintendent of the Examination concerned.</p> <p>The Superintendent of Examination shall arrange for a suitable room for the disabled candidate and appoint a Special Invigilator from the list supplied by the office of the Controller of Examinations.</p>
