<p>2.3 Modalities for Non-NET Fellowships for M.Phil Students</p> <p>(ii) The progress of an M.Phil. Student during the first and second semesters of the programme shall be assessed on the basis of his/her class attendance and performance in the 1st and 2nd Semester Examinations.</p> <p>A student who is short of the requisite attendance or is unable to secure at least 50% marks or equivalent grade in any of the Courses of the 1st/ 2nd Semester Examination, his/her Non-NET fellowship shall be discontinued. Such a student will not be entitled to get the said fellowship even after he/she is re-admitted to the next semester of the M.Phil. programme.</p>	<p>2.3 Modalities for Non-NET Fellowships for M.Phil Students</p> <p>(ii) ----- No Change -----</p> <p>A student who is short of requisite attendance fellowship shall be discontinued. Such a student will only be eligible to get the said fellowship if he/she clears all backlog papers of 1st and 2nd Semesters.</p>
