Amendment in Para 2.0 of Ordinance 6 (VI) [Academic] captioned "Reservation of seats and other Special Provision for Admission" vide E.C. Resolution No.EC-2014 (I):Reso-3.6 dated 03.03.2014

**Ordinance 6 (VI) {Academic}
"Reservation of seats and other special provision for admission"**

| Para No. | Existing | Amended |

| 2.0 | <p>Persons with Disabilities</p> <p>3 % seats in all courses will be reserved for physically challenged persons in accordance with the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act 1995. Candidates under this category will be given relaxation to the extent of 5 % marks in the qualifying examination. Provided that only such persons would be considered for admission under this category who are suffering from not less than 40% of a physical disability as certified by a competent medical authority.</p> <p>It is clarified that the maximum prescribed period (s)-for passing the examination of a course shall be extended by two years in case of Physically Challenged Persons. However, in exceptional cases, the Shaikhul Jamia (Vice Chancellor) may further extend the said period by one year.</p> | <p>Persons with Disabilities</p> <p>3% seats in all programmes in the lamia Millia Islamia shall be reserved for the physically challenged persons in accordance with the provisions of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 under the following categories {to the extent of 1% each, and interchangeable intra in case of non availability of eligible Applicants}:</p> <ul style="list-style-type: none"> i) Blindness/low vision; ii) Hearing impairment; iii) Locomotor disability or cerebral palsy. <p>Candidates under this category will be given relaxation to the extent of 5 marks in the qualifying examination.</p> <p>Unless and otherwise provided, only such candidates shall be considered under this category who are suffering from not less than 40% of disability as certified by a competent medical authority.</p> <p>Provided that in the Faculty of Dentistry, 3% seats of the annual sanctioned intake capacity shall be filled by candidates with locomotory disability of lower limbs between 50% to 70% will be considered. In case of unavailability of such candidates, unfilled seats in this 3% quota shall be filled up by persons with locomotory disability of lower limbs between 40% to 50% before they are included in the annual sanctioned seats for General Category candidates as per the DCI Gazette notification.</p> <p>It is clarified that the maximum prescribed period for passing the examination of a course shall be extended by two years for candidates in this category. However, in exceptional cases, the Shaikhul lamia (Vice-Chancellor) may further extend the said period by one more year.</p> |
