"AGE OF RETIREMENT OF STAFF"**

1	<p>All the whole time teachers of the Jamia shall retire from the service of the Jamia with effect from the date on which they attain the age of 60 years. The Majlis-i-Muntazimah, on the recommendation of the Shaikh-ul-Jamia, may however, in the interest of the Jamia, re-employ a teacher for such period as it may deem fit and on such terms and conditions as it may prescribe. Provided that:</p> <p>(1) no teacher shall remain in the Jamia's service beyond the age of 65 years; and</p> <p>(2) no administrative responsibility will be given to a re-employed employee.</p>	<p>1.
