## MEMORANDUM OF UNDERSTANDING

**UNIVERSITY OF SARGODHA,  
SARGODHA, PAKISTAN**

*And*

**THE JAMIA MILLIA ISLAMIA  
DELHI, INDIA**

In the interest of maintaining a collaborative relationship of mutual benefit, and for the purpose of jointly undertaking educational and scholarly activities mutually acceptable to the two institutions: the **University of Sargodha, Sargodha (Pakistan)**, and the **Jamia Millia Islamia, Delhi, (India)** hereby agree as follows:

### ARTICLE 1 – OBJECTIVES

The objective of this agreement is to combine efforts of the two institutions to stimulate cooperation and strengthen teaching, research and extension / outreach to promote the research related to common history and the allied aspects of the region to find the solutions mutually beneficial to both institutions.

### ARTICLE 2 – AREAS OF COOPERATION

The cooperation can involve:

- a) collaboration in research and training on all areas related to Languages, Natural and Social Sciences;
- b) training of researchers, specialists, teaching staff, graduate students and student interns;
- c) organisation of seminars and / or technical conferences, and;
- d) production, acquisition and distribution of appropriate publications etc.

### ARTICLE 3 – COORDINATION

On behalf of the **University of Sargodha, Sargodha (Pakistan)**, the **Registrar** will serve as the coordinator to liaise mutual activities between the two organisation. The **Registrar** will serve as coordinator on behalf of **Jamia Millia Islamia, Delhi, (India)**.

The two institutions will designate individuals as appropriate officials to coordinate joint activities on behalf of their universities. The Heads of various Departments will serve as the key contact persons for initial discussions of each joint activity between the two institutions.



#### ARTICLE 4 – RESOURCES AND INSTITUTIONAL CONTRIBUTIONS

- 1) Institutional Contributions
  - a) Human resources, research materials and financial resources as available, necessary for the execution of the activities to be conducted by **University of Sargodha, Sargodha (Pakistan) and Jamia Millia Islamia, Delhi, India;**
  - b) **Jamia Millia Islamia, Delhi, (India)** and **UOS** shall, together and independently, pursue opportunities for additional financial support to further the objectives of this memorandum.
  
- 2) University of Sargodha, Sargodha and Jamia Millia Islamia, Delhi aim to:
  - a) assist, when possible, with graduate and postgraduate training of **UOS** staff. The costs of travel and training for such staff members will be borne by **UOS** or through outside funding obtained by **UOS** or jointly with **Jamia Millia Islamia, Delhi**
  - b) assist with the planning of collaborative research and joint development of funding for such research by **UOS** and the counterpart of **Jamia Millia Islamia, Delhi, (India)** when appropriate interest and funding exists;
  - c) assist with documentation of research information and data, and joint publication of research results in the both countries; and,
  - d) arrange for **UOS** and **Jamia Millia Islamia, Delhi, (India)** staff exchanges when faculty and staff interests and appropriate funding exist.
  - e) Assist with official in-country clearance, e.g. research permissions, VISAs, customs documents, etc. for visiting faculty of **UOS** personnel as needed.
  
- 3) **University of Sargodha, Sargodha (Pakistan) and Jamia Millia Islamia, Delhi, India** will aim to:
  - a) provide opportunity for faculty and staff to participate in research, extension and teaching;
  - b) assist with the planning of collaborative research and joint development of funding for such research by faculty when appropriate interest and funding opportunities exist;
  - c) assist with documentation of research information and data, and joint publication of research results in the language of both countries; and,
  - d) arrange for faculty exchanges when faculty and staff interests and appropriate funding exist.
  - e) assist with official in-country clearance, e.g. research permissions, VISAs customs documents etc. for personnel, as needed.

#### ARTICLE 5 – OBLIGATIONS

- 1) **Jamia Millia Islamia, Delhi** will be responsible for:
  - a) selection and approval of **Jamia Millia Islamia's** personnel to be involved in joint activities with, **University of Sargodha, Sargodha;**
  - b) assisting with the visits (e.g., agendas, arranging housing, meeting of all **Jamia Millia Islamia** rules and procedures, etc.) of faculty, **University of Sargodha, Sargodha** researchers visitors to **Jamia Millia Islamia, Delhi;**
  - c) access to **Jamia Millia Islamia, Delhi,** facilities; and,
  - d) provision of related means to facilitate the activities.



- 2) **University of Sargodha** will be responsible for:
  - a) selection and approval of **UOS** personnel to be involved in joint activities with, **Jamia Millia Islamia**;
  - b) assisting with the visits (e.g., agendas, arranging housing, meeting of all **UOS** rules and procedures, etc.) of faculty **JMI** researchers visitors to **UOS**;
  - c) access to **UOS** facilities; and,
  - d) provision of related means to facilitate the activities.

#### **ARTICLE 6 – PUBLICATIONS**

- 1) Results of joint activities will be published in **English**. Mutual exchange of publications produced by, **UOS** and **JMI** will be encouraged.

#### **ARTICLE 7 – FISCAL EXEMPTIONS**

In accordance with Indian and Pakistani governments regulations pertaining to the Universities, the equipment, materials, and supplies imported for the realisation of this memorandum will be exempted from taxes and import duties.

#### **ARTICLE 8 – CONSULTATION AND EVALUATION**


- 1) To facilitate the execution of the program, there will be periodic communications and consultations between the two parties.
- 2) The two institutions assume the responsibility of providing for evaluation and reporting of the activities developed under this agreement.

#### **ARTICLE 9 – LIFE OF THIS AGREEMENT**

The present agreement will remain in effect, upon being signed, for a period of five (5) years, with the option of extending it. The agreement may be terminated by either party with six (6) months notification, in writing.


