

## MEMORANDUM OF UNDERSTANDING

between

**Government College University, Faisalabad, Pakistan**

*herein referred to as GCUF*

and

**Jamia Millia Islamia, New Dehli, India**

*herein referred to as Jamia*

With a mutual desire of developing strong partnership between **GCUF** and the **Jamia**, the two universities wish to enter into this Agreement, subject to the terms and conditions hereinafter provided.

### 1. STATEMENT OF OBJECTIVE

**GCUF** and the **Jamia** recognize the need for understanding, sharing of expertise and resources in the attainment of their goals and the objective of providing relevant quality education and training to their students. This could be achieved through the sharing of faculty and other resources between the two universities. Whereas to this purpose, the objective of this memorandum is to provide a framework within which collaborative activities and projects may be undertaken by **GCUF** and the **Jamia**.

### 2. SCOPE OF COOPERATION

Within the disciplines that are mutually acceptable, the two universities shall promote opportunities to pursue cooperative efforts that that may in include (but not limited to):

- i) Collaboration in developing and facilitating education and training programmes for students in degree and non-degree programmes.
- ii) Exchange of faculty, staff and students for the purpose of research education and development.
- iii) Information exchange, including but not limited to faculty and staff development opportunities, library material and other facilities as mutually agreed.
- iv) Any other agreed joint collaborative activity.

### 3. SPECIAL PROVISION


- i) **GCUF** and the **Jamia** will define each area of collaboration. Specific project and activities under this memorandum may be developed as per agreement by both universities.
- ii) Both parties accept that all activities under this Memorandum are subject to the availability of financial resources and that availability of such resources should be negotiated prior to initiation of the activity.
- iii) **GCUF** and the **Jamia** hereby acknowledge their agreement in principle to the framework of cooperation outlined in this Memorandum of Understandings; however this shall not give any specific rights and obligation to either university, unless such rights and privileges are mutually set forth in definite terms by both universities.
- iv) Any notification to this Memorandum may be made only by mutual consent in writing between the authorized representatives of the two universities.

### 4. TERMINATION

Either party may terminate this Memorandum at any time by giving at least one year notice in writing to the other party. Such action will be taken after mutual consultation in order to avoid any possible inconvenience to all concerned. Regardless of termination, the universities shall continue to fulfill their obligations here under until all projects and activities commenced under the agreement may complete their duration.

The Agreement shall continue to stay in force unless both parties express in writing to withdraw from the cooperation.
