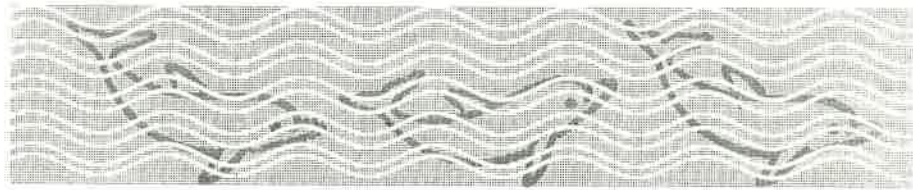
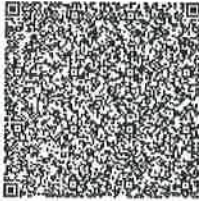

### MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is executed on this 29<sup>th</sup> June, 2021 at New Delhi.

BETWEEN

JAMIA MILLIA ISLAMIA, New Delhi a Central University by an Act of Parliament of India (i.e. Jamia Millia Act, 1988) and is a body corporate with a perpetual succession and a common seal (acting through its Registrar presently Dr. Nazim Husain Jafri, as its authorized signatory) (hereinafter referred as 'JMI').

#### Statutory Alert:

2. The onus of checking the legitimacy is on the users of the certificate.
3. In case of any discrepancy please Inform the Competent Authority.

- a) Clinical training in the area of Medicine, Surgery and allied subjects for a period of one year w.e.f. 01.07.2021 to 30.06.2022 or till their own hospital is commissioned.
- b) The license to access ESIC would be inclusive of utilization of facilities, interaction with medical and para-medical staff, understanding patients and disease by JMI students.
- c) JMI shall be liable to pay a sum of Rs. 1,000/- (Rupees one thousand only) for each registered student on an annual basis for services rendered by ESIC as agreed to in Clauses (a) & (b) hereinabove with effect from 01.07.2021.
- d) JMI will provide all necessary assistance regarding Faculty and other academic support for establishment of Dental Colleges in ESIC Hospital.
- e) JMI shall be responsible for any loss or damages to the properties belonging to ESIC caused by the students or staff of JMI.
- f) The JMI acknowledges that any breach during the training period by its staff or students could result in significant losses or damages to ESIC, Jamia Millia Islamia agrees to indemnify ESIC in respect of all claims, demands, actions, causes of action, losses and damages which ESI may suffer or incur, or which may be brought against ESIC as a result or in any way arising out of any breach by the staff and students of JMI.

2. **MISCELLANEOUS:**

- a) The details for the efficacious implementation of this memorandum of Understanding shall be jointly worked out on a mutually acceptable terms within the parameters of the policies, rules and regulations of both the institutions.
- b) The parties to this Memorandum may, by mutual consent, add modify, amend, delete review or revise any term(s) and condition(s) of this Memorandum.
- c) Without prejudice to the generality of the co-operation as incorporated in this MOU, the parties herein may sign collaborative agreements in other fields of common interest.
- d) Disputes, if any, arising out of this Memorandum of intent and /or its enforcement shall be referred to arbitration under the Arbitration & Conciliation Act; 1996.



**AND**

DIRECTOR GENERAL, ESI Corporation, Ministry of Labour Government of India, New Delhi through its Medical Superintendent, ESIC Hospital, Okhla, Medical Commissioner as its authorized signatory (hereinafter referred ESIC).

WHEREAS, it is the statutory objective of the JMI to disseminate and advance knowledge by providing instructional research and extension facilities in such branches of learning as it may deem, fit and it shall endeavour to provide to students and teachers the necessary atmosphere and facilities for the promotion of:

- (i) Innovations in education leading to restricting of courses, new methods of teaching and learning and integral development of personality.
- (ii) Studies in various disciplines,
- (iii) Interdisciplinary studies.
- (iv) National integration, secularism and international understanding.

AND WHEREAS the 251 bed ~~General~~ Hospital (presently 251 functional beds) of ESIC at Okhla, Phase-I, New Delhi is a hospital with excellent facilities in management and treatment of various diseases.

AND WHEREAS, the JMI has established a Faculty of Dentistry which offers Bachelor of Dental Surgery (BDS) Course.

AND WHEREAS for the purpose of clinical training of its students, Jamia Millia Islamia has chosen ESIC Hospital, Okhla Phase-I as Centre for imparting the clinical and practical training to its BDS students at ESIC Hospital Okhla, in the disciplines of Medicine, Surgery and other related subjects.

AND WHEREAS, for the purpose of synergistically combining the strengths of the two organization for mutual interest in the field of academics matter. ESIC has agreed to allow the dental students of JMI to pursue their training on the terms and conditions as hereto agreed upon by and between the two parties.

NOW THEREFORE the JMI ESIC intended, agreed and consented to the following terms and deeds in pursuance of a common intent to promote and develop the study of dentistry.



## 1. FIELD OF CO-OPERATION

Both JMI and ESIC shall consent to the following terms & conditions:-

- a) ESIC 251 bedded ~~General~~ Hospital, Okhla, Phase-I New Delhi shall allow coordinated access to the staff and students of JMI for the purpose of the clinical training.
